WHEREAS, G.S.160A-282 provides that a city by enactment of an ordinance may provide that while undergoing officer training and while performing duties on behalf of the city pursuant to orders or instructions of the of the Chief of Police, auxiliary law enforcement personnel officers shall be entitled to benefits under the North Carolina Workers' Compensation Act; and

**WHEREAS**, the Charlotte-Mecklenburg Police Department maintains an auxiliary police unit called the "Charlotte-Mecklenburg Police Reserves" who are assigned to work special events and other law enforcement functions.

**NOW, THEREFORE BE IT ORDAINED** by the City council of the City of Charlotte, North Carolina, that:

<u>Section 1</u>. Chapter 16, "Police" of the Charlotte City Code is amended by adding a new section, Section 16-30, to read as follows:

### "Section 16-30. Workers' Compensation for Reserve Officers

Sec. 16-30: Workers Compensation for Charlotte-Mecklenburg Police Reserve Officers

(a) A Charlotte-Mecklenburg Reserve Officer who is injured while undergoing official training or while performing official law enforcement duties on behalf of the City, shall be entitled to benefits pursuant to law under the North Carolina Workers' Compensation Act.






