ORDINANCE NO. 3510

AMENDING CHAPTER 11

**ORDINANCE AMENDING THE CHARLOTTE CITY CODE**

Chapter 11 of the Charlotte City Code is amended by deleting Sec. 11- 33 and adding the following:

“Reserved”

Chapter 11 of the Charlotte City Code is amended by adding to subsection (d) of Sec. 11-45 the following:

“(13) Every dwelling shall comply with the current county health regulations governing carbon monoxide alarms.”

Chapter 11 of the Charlotte City Code is amended by adding to Section 11-83 the following:

“(h) Window bars, grills, or other impediments to escape in case of fire shall not be permitted at habitable room windows, except as permitted by the state building code.”

Chapter 11 of the Charlotte City Code is amended by rewriting subsection (b) (3) of Sec. 11-83 to read as follows:

“Joists and beams shall not be overloaded, sagging or broken and shall be structurally sound and not likely to cause structural weakness in the future.”

Chapter 11 of the Charlotte City Code is amended by rewriting subsection (b) (4) of Sec. 11-83 to read as follows:

“Maximum spans for floor joists, beams and sills, providing they show signs of being weak or overloaded, shall comply with the requirements of the state building code.”

Chapter 11 of the Charlotte City Code is amended by rewriting subsection (c) (5) of Sec. 11-83 to read as follows:

“All siding shall be weathertight, with no holes or excessive cracks or decayed boards, or siding material which permits air to penetrate rooms.”

Chapter 11 of the Charlotte City Code is amended by rewriting subsection (e) (1) of Sec. 11-83 to read as follows:

“There shall be no joists, or beams which are decayed, broken, sagging, or improperly

supported at the ends.”

Chapter 11 of the Charlotte City Code is amended by rewriting subsection (e) (7) of Sec. 11-83 to read as follows:

“Ceiling joists, and beams shall be structurally sound and not likely to cause structural weakness in the future.”

Chapter 11 of the Charlotte City Code is amended by rewriting subsection (g) (2) of Sec. 11-83 to read as follows:

“Every porch, terrace or entrance platform 30 inches or more above the adjacent finished grade shall be equipped with railings or guards not less than 36 inches high, unless other effective barriers provide adequate safety. Guard opening limitations shall conform to the requirements of the State Building Code”


