

ORDINANCE NO. 3464

AMENDING CHAPTER 22

**AN ORDINANCE AMENDING CHAPTER 22 OF THE CITY CODE OF CHARLOTTE ENTITLED "VEHICLES FOR HIRE"**

**BE IT ORDAINED** by the City Council of the City of Charlotte, North Carolina, that:

Section 1. Section 22-141 of the City Code shall be amended to add a phrase at the end of the subsection to read as follows:

"as authorized by G.S. §160A-304, which is herein incorporated by reference."

Section 2. Subsection (6) of Section 22-142 of the City Code shall be amended by deleting this subsection.

Section 3. Subsection (b) of Section 22-142 of the City Code shall be amended by deleting the first sentence of this section and replacing it with additional language to read as follows:

"The applicant is required to provide his/her fingerprints which will be submitted to state and national criminal history checks of his/her criminal record. The Passenger Vehicle for Hire Manager of the City shall forward the applicant's fingerprints to the State Bureau of Investigation for a search of the State's criminal history record file and the State Bureau of Investigation shall forward a set of the fingerprints to the Federal Bureau of Investigation for a national criminal history check in accordance with G.S. §160A-304. This information shall be kept privileged and confidential and shall not be a public record under Chapter 132 of the General Statutes. The receipt by the City Passenger Vehicle for Hire Manager of the Criminal History Record Check shall be used solely to determine eligibility for a permit."

Section 4. This ordinance shall take effect upon adoption.
