AN ORDINANCE TO AMEND ORDINANCE NUMBER 3606-X, THE 2007-2008 BUDGET ORDINANCE, APPROPRIATING \$294,500 FROM THE AIRPORT DISCRETIONARY FUND FOR THE NOISE COMPATIBILITY PROGRAM, TO BE REPAID WITH FUTURE FEDERAL GRANTS AND PROCEEDS FROM FUTURE GENERAL REVENUE BONDS.
