AN ORDINANCE TO AMEND ORDINANCE NUMBER 3606-X, THE 2007-2008 BUDGET ORDINANCE, APPROPRIATING \$4,624,000 IN EXCLUDED CENTERS FUND BALANCE FOR CONSTRUCTION OF AN APPROXIMATELY 40,000 SQUARE FOOT HANGAR BY MORLANDO-HOLDEN CONSTRUCTION.

BE IT ORDAINED, by the City Council of the City of Charlotte;

- Section 1. That the sum of \$4,624,000 is available from excluded centers fund balance to be repaid from future permanent financing.
- Section 2. That the sum of \$4,624,000 is hereby appropriated to the Airport Capital Projects Fund: 2073 563.28
- Section 3. That the existence of the project may extend beyond the end of the fiscal year.

  Therefore, this ordinance will remain in effect for the duration of the program and funds are to be carried forward to subsequent fiscal years until all funds are expended.
- Section 4. All ordinances in conflict with this ordinance are hereby repealed.

AN ORDINANCE TO AMEND ORDINANCE NUMBER 3306-X, THE 2007-2008 BUDGET ORDINANCE, ESTIMATING AND APPROPRIATING FUNDING FROM THE NORTH CAROLINA HOUSING FINANCE AGENCY TO CONTINUE THE URGENT HOUSING REPAIR PROGRAM.

# AN ORDINANCE TO EXTEND THE CORPORATE LIMITS OF THE CITY OF CHARLOTTE, NORTH CAROLINA

WHEREAS, the City Council has been petitioned under G.S. 160A-31 to annex the area described below; and

WHEREAS, the City Clerk has certified the sufficiency of the petition and a public hearing on the question of this annexation was held in the Meeting Chamber of the Charlotte-Mecklenburg Government Center, 600 E. Fourth Street, Charlotte, N.C. at 7:00 p.m. on \_\_\_March 24, 2008 \_\_ after due notice by the Mecklenburg Times on \_March 11, 2008 ; and

WHEREAS, the City Council finds that the petition meets the requirements of G.S. 160A-31;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina that:

Section 1. By virtue of the authority granted by G.S. 160A-31, the following described territory is hereby annexed and made part of the City of Charlotte as of March 24, 2008 (effective date):

## LEGAL DESCRIPTION

Being a portion of the tract of land located in the City of Charlotte, Mecklenburg County, North Carolina and recorded in map book 49, page 243 in the Mecklenburg County Register of Deeds and being more particularly described as follows:

RETURNED TO CUSTOMER

The Mayor of the City of Charlotte shall cause to be recorded in the office of the Register of Deeds of Mecklenburg County, and in the office of the Secretary of State at Raleigh, North Carolina, an accurate map of the annexed territory, described in Section 1 above, together with a duly certified copy of this ordinance. Such a map shall also be delivered to the County Board of Elections, as required by G.S. 163-288.1.


