**AN ORDINANCE TO AMEND ORDINANCE NUMBER 3606-X, THE 2007-2008 BUDGET  
ORDINANCE,  
APPROPRIATING \$61,574,033 FROM THE AIRPORT DISCRETIONARY FUND BALANCE FOR  
PAVING AND LIGHTING OF THE THIRD PARALLEL RUNWAY.**

BE IT ORDAINED, by the City Council of the City of Charlotte;

- Section 1. That the sum of \$61,574,033 is available from airport discretionary fund balance to be repaid from proceeds from future federal grants and 2008 General Airport Revenue Bond funds.
- Section 2. That the sum of \$61,574,033 is hereby appropriated to the Airport Capital Projects Fund:  
2091 - 554.12
- Section 3. That the existence of the project may extend beyond the end of the fiscal year. Therefore, this ordinance will remain in effect for the duration of the program and funds are to be carried forward to subsequent fiscal years until all funds are expended.
- Section 4. All ordinances in conflict with this ordinance are hereby repealed.
- Section 5. This ordinance shall be effective upon adoption.

Section 1. That the sum of \$534,500 is available from airport discretionary fund balance to be repaid by rents from users of the hangar.


Section 2. That the sum of \$534,500 is hereby appropriated to the Airport Capital Projects Fund:


