

AN ORDINANCE TO REPEAL AN ORDINANCE IMPOSING A MONTHLY 911 CHARGE UPON EACH EXCHANGE ACCESS FACILITY IN THE AREA SERVICED BY THE CHARLOTTE-MECKLENBURG POLICE DEPARTMENT

WHEREAS, on May 14, 2001, the City Council passed Ordinance 1807-X (Ordinance Book 51, Page 33) which imposed a monthly 911 charge on each exchange access facility subscribed to by all telephone subscribers whose exchange lines were in the area served or would be served by the City's enhanced 911 service;

WHEREAS, the monthly charge was uniform and did not vary according to the type of exchange access facility used, and was collected by the subscriber's service provider and remitted to the City;

WHEREAS, Session Law 2007-383 consolidated the State's Enhanced 911 System under a single board and also established a uniform 911 service charge;

WHEREAS, Session Law 2007-383 enacted a new section of the North Carolina General Statutes, Section 62A-43(f), which expressly provided that, "A local government may not impose a service charge or other fee on a subscriber to support the 911 system;" and

WHEREAS, Session Law 2007-383 effectively overrules the City's ability to collect 911 service charges, and by effect, prohibits what is permitted by Ordinance 1807-X and overrules the ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE, NORTH CAROLINA THAT:

WHEREAS, the City and the County entered into that certain Restated

Consolidated Shared Joint Undertaking Agreement ("Agreement") made as of July 1,

1998, which Agreement specifies the details and the financing of various programs or

joint undertakings which are operated by one government or report for budget purposes

to one government for the mutual benefit of both governments; and

WHEREAS, the City and County now desire to amend the portion of the Agreement dealing with "911 Public Safety Emergency Telephone Service" to reflect subsequent changes in State law.

NOW, THEREFORE, in consideration of the premises and the fulfillment of the terms of this Amendment to the Agreement, the City and County agree as follows:

Paragraph 1.(A)(11) of the Agreement which currently reads "Public Safety Telephone Service" is amended to read "Emergency Telephone Service".

Paragraph 5.(A)(11) is amended to read:

"(11) "Emergency Telephone Service" – Pursuant to G.S. Sec. 62A-40 et seq., as between the City and the County, the City is the primary public safety answering point

(PSAP) and is, therefore, entitled to the distribution of funds from the 911 Board pursuant to G.S. Sec. 62A-46.

Notwithstanding the fact that the City is entitled to the entire local 911 Board distribution, the City recognizes the value in coordinating police, fire, and MEDIC emergency telephone services. Consistent with that recognition, the City and the County agree that as part of their annual budget process, the Charlotte-Mecklenburg Police Department (CMPD), the Charlotte Fire Department (CFD), and MEDIC will jointly develop an emergency telephone service budget based on the projected 911 Board distribution and any available emergency telephone service fund balance. In the event that CMPD, CFD, and MEDIC are unable to agree on an emergency telephone service budget, the matter will be referred to the City and County Managers for resolution. In the event that the City and County Managers are unable to agree on an emergency telephone service budget, the Charlotte City Council will establish the emergency telephone service budget as part of the City's budget.

Once the emergency telephone service budget has been established and adopted by the City, MEDIC shall submit invoices to the City requesting reimbursement for items paid by the County that were included in the budget."




