A Regular Meeting of the City Council of the City of Charlotte, North Carolina was duly held in the Meeting Chamber at the Charlotte-Mecklenburg Government Center in Charlotte, North Carolina, the regular place of meeting, at 7:00 p.m. on March 25, 2013:

Councilmember Mayor Foxx introduced the following resolution, a summary of which had been provided to each Councilmember, copy of which was available with the City Council and which was read by title:

RESOLUTION OF THE CITY OF CHARLOTTE, NORTH CAROLINA APPROVING AN AMENDMENT TO AN INSTALLMENT PURCHASE CONTRACT AND RELATED MATTERS

WHEREAS, the City of Charlotte, North Carolina (the "*City*") is a municipal corporation validly existing under the Constitution, statutes and laws of the State of North Carolina (the "*State*");

WHEREAS, the City has the power, pursuant to the General Statutes of the State, to (1) purchase real and personal property, (2) enter into installment purchase contracts to finance and refinance the purchase of real and personal property used, or to be used, for public purposes, and (3) grant a security interest in some or all of the property purchased to secure repayment of the purchase price;

WHEREAS, the City previously executed and delivered an Installment Purchase Contract dated as of December 1, 2003, as previously amended (the "*2003 Contract*") between the City and New Charlotte Corporation (the "*Corporation*"), in order to finance mass transit facilities and equipment;

WHEREAS, to secure its obligations under the 2003 Contract, the City (1) executed and delivered a Deed of Trust and Security Agreement dated as of December 1, 2003, as previously amended (the "*2003 Deed of Trust*"), granting the Corporation a security interest in certain transit facilities acquired with the proceeds of the 2003 Contract, and (2) granted the Corporation under the 2003 Contract a security interest in certain personal property acquired with the proceeds of the 2003 Contract;

WHEREAS, in connection with the 2003 Contract, the City previously executed and delivered under an Indenture of Trust dated as of December 1, 2003, as previously amended and supplemented (the "2003 Indenture"), between the Corporation and Wachovia Bank, National Association, the successor to which is U.S. Bank National Association, as trustee (the "Trustee"), several series of certificates of participation, including its Certificates of Participation (Transit Projects), Series 2004A (the "2004A Certificates"), each evidencing proportionate undivided interests in rights to receive certain revenues pursuant to the 2003 Contract;

WHEREAS, consistent with the City's financial policies for the Charlotte Area Transit System ("CATS"), the City Council of the City of Charlotte, North Carolina (the "City Council") has determined that it is in the best interests of the City to enter into Amendment Number Three to the Installment Purchase Contract dated as of May 1, 2013 (the "Contract Amendment," and together with the 2003 Contract, the "Contract") between the City and the Corporation in order (a) to finance the acquisition, construction and equipping of improvements to the City's LYNX Blue Line, commonly referred to as the Blue Line Extension (the "2013 Projects"), (b) refinance a portion of the City's installment payment obligations under the Contract corresponding to the 2004A Certificates maturing on and after June 1, 2014 (the "Refunded 2004A Certificates") and (c) pay certain costs related to the execution and delivery of the Contract Amendment;

WHEREAS, to provide additional security for the City's obligations under the Contract, the City will (1) execute and deliver a Notice of Extension and Amendment to Deed of Trust dated as of May 1, 2013 (the "Deed of Trust Amendment," and together with the 2003 Deed of Trust, the "Deed of Trust") to amend the 2003 Deed of Trust and to grant a lien on the City's fee simple interest in all or a portion of the real property on which the 2013 Projects are or will be located and (2) grant under the Contract Amendment a security interest in certain personal property acquired with proceeds of the Contract Amendment;

WHEREAS, in connection with the execution and delivery of the Contract Amendment, the Corporation will execute and deliver (1) Certificates of Participation (Transit Projects/Phase III), Series 2013B (the "2013B Certificates") and (2) Refunding Certificates of Participation (Transit Projects) Series 2013C (the "2013C Certificates," and together with the 2013B Certificates, the "2013BC Certificates"), each evidencing proportionate undivided interests in rights to receive certain revenues pursuant to the Contract, under the 2003 Indenture and Supplemental Indenture, Number Four dated as of May 1, 2013 (the "Fourth Supplement") between the Corporation and the Trustee;

WHEREAS, the Corporation will also execute and deliver (1) Certificates of Participation (Transit Projects/Phase III), Series 2013D (the "2013D Certificates"), (2) Certificates of Participation (Transit Projects/Phase III), Series 2013E (the "2013E Certificates") and (3) Certificates of Participation (Transit Projects/Phase III), Series 2013F (the "2013F Certificates," and together with the 2013D Certificates and the 2013E Certificates, the "2013DEF Certificates"), each evidencing proportionate undivided interests in rights to receive certain revenues pursuant to the Contract, under the 2003 Indenture and Supplemental Indenture, Number Five dated as of May 1, 2013 (the "Fifth Supplement") between the Corporation and the Trustee;

WHEREAS, in connection with the sale of the 2013BC Certificates to Merrill Lynch, Pierce, Fenner & Smith Incorporated and Wells Fargo Bank, National Association (collectively, the "Underwriters"), the Corporation will enter into a Contract of Purchase to be dated on or about

April 17, 2013 (the "*Purchase Contract*") among the Corporation and the Underwriters and the City will execute a Letter of Representations to the Underwriters (the "*Letter of Representations*");

WHEREAS, in connection with the sale of the 2013DEF Certificates to Banc of America Preferred Funding Corporation (the "*Purchaser*"), the City will enter into a Covenants Agreement dated as of May 1, 2013 (the "*Covenants Agreement*") among the City, the Corporation and the Purchaser;

WHEREAS, there has been described to the City Council the following documents (collectively, the "*Instruments*"), copies of which have been made available to the City Council, which the City Council proposes to approve, enter into and deliver, as applicable, to effectuate the proposed installment purchase financing:

- (1) the Contract Amendment;
- (2) the Deed of Trust Amendment;
- (3) the Letter of Representations;
- (4) the Purchase Contract;
- (5) the Covenants Agreement;
- (6) the Fourth Supplement;
- (7) the Fifth Supplement; and
- (8) a Supplemental Indenture, Number Six dated as of May 1, 2013 (the "*Sixth Supplement*," and together with the Fourth Supplement and the Fifth Supplement, the "*Supplements*") between the Corporation and the Trustee;

WHEREAS, to make an offering and sale of the 2013BC Certificates, there will be prepared a Preliminary Official Statement (the "*Preliminary Official Statement*"), a draft thereof having been presented to the City Council, and a final Official Statement (collectively with the Preliminary Official Statement, the "*Official Statement*") with respect to the 2013BC Certificates, which Official Statement will contain certain information regarding the City;

WHEREAS, it appears that each of the Instruments and the Preliminary Official Statement is in an appropriate form and is an appropriate instrument for the purposes intended;

WHEREAS, the City Council has conducted public hearings to receive public comment on the 2003 Contract and the projects financed and refinanced thereby, and the City Council conducted a public hearing on March 25, 2013 to receive public comment on the proposed Contract Amendment and the projects to be financed and refinanced thereby; and

WHEREAS, the City has filed an application to the LGC for approval of the Contract Amendment;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE, NORTH CAROLINA, AS FOLLOWS:

Section 1. Ratification of Instruments. All actions of the City, the City Manager, the Chief Financial Officer, the City Clerk, the City Attorney and their respective designees, whether previously or hereinafter taken, in effectuating the proposed financing are hereby approved, ratified and authorized pursuant to and in accordance with the transactions contemplated by the Instruments.

Section 2. Authorization of the Official Statement. The form, terms and content of the Official Statement are in all respects authorized, approved and confirmed, and the use of the Official Statement by the Underwriters in connection with the sale of the 2013BC Certificates is hereby in all respects authorized, approved and confirmed.

Section 3. Authorization to Execute the Contract Amendment. The City approves the financing of the 2013 Projects and the refunding of the Refunded 2004A Certificates in accordance with the terms of the Contract Amendment, which will be a valid, legal and binding obligation of the City in accordance with its terms. The form and content of the Contract Amendment are hereby authorized, approved and confirmed in all respects, and the City Manager or the Deputy City Manager and the City Clerk and their respective designees are hereby authorized, empowered and directed, individually and collectively, to execute and deliver the Contract Amendment, including necessary counterparts, in substantially the form and content presented to the City Council, but with such changes, modifications, additions or deletions therein as they may deem necessary, desirable or appropriate, their execution thereof to constitute conclusive evidence of the City's approval of any and all changes, modifications, additions or deletions therein from the form and content of the Contract Amendment presented to the City Council. From and after the execution and delivery of the Contract Amendment, the City Manager, the Chief Financial Officer and the City Clerk are hereby authorized, empowered and directed, individually and collectively, to do all such acts and things and to execute all such documents as may be necessary to carry out and comply with the provisions of the Contract Amendment as executed.

Section 4. Authorization to Execute the Deed of Trust Amendment. The City approves the form and content of the Deed of Trust Amendment, and the Deed of Trust Amendment is hereby authorized, approved and confirmed in all respects. The City Manager or the Deputy City Manager and the City Clerk and their respective designees are hereby authorized, empowered and directed, individually and collectively, to execute and deliver the Deed of Trust Amendment, including necessary counterparts, in substantially the form and content presented to the City Council, but with such changes, modifications, additions or deletions therein as they may deem necessary, desirable or appropriate. Execution by the City Manager or the Deputy City Manager and the City Clerk or their respective designees shall constitute conclusive evidence of the City's approval of any and all such changes, modifications, additions or deletions therein from the form and content of the Deed of Trust Amendment presented to the City Council, and from and after the execution and delivery of the Deed of Trust Amendment, the City Manager, the City Clerk and the Chief Financial Officer of the City are hereby authorized, empowered and directed, individually and collectively, to do all such acts and things and to execute all such documents as may be necessary to carry out and comply with the provisions of the Deed of Trust Amendment as executed.

Section 5. Authorization to Execute the Covenants Agreement. The form and content of the Covenants Agreement are hereby authorized, approved and confirmed in all respects, and the City Manager or the Deputy City Manager and the City Clerk and their respective designees are hereby authorized, empowered and directed, individually and collectively, to execute and deliver the Covenants Agreement, including necessary counterparts, in substantially the form and content presented to the City Council, but with such changes, modifications, additions or deletions therein as they may deem necessary,

desirable or appropriate, their execution thereof to constitute conclusive evidence of the City's approval of any and all changes, modifications, additions or deletions therein from the form and content of the Covenants Agreement presented to the City Council. From and after the execution and delivery of the Covenants Agreement, the City Manager, the Chief Financial Officer and the City Clerk are hereby authorized, empowered and directed, individually and collectively, to do all such acts and things and to execute all such documents as may be necessary to carry out and comply with the provisions of the Covenants Agreement as executed.

Section 6. Letter of Representation. The form and content of the Purchase Contract are hereby approved in all respects, and the City Manager or the Deputy City Manager is authorized to execute the Letter of Representation for the purposes stated therein.

Section 7. Supplements. The form and content of each Supplement are hereby approved in all respects.

Section 8. City Representative. The City Manager, the Deputy City Manager, the Chief Financial Officer, the City Treasurer and the City Debt Manager are hereby designated as the City's representatives to act on behalf of the City in connection with the transaction contemplated by the Instruments and the Official Statement, and each is authorized to proceed with the financing of the 2013 Projects and the refunding of the Refunded 2004A Certificates in accordance with the Instruments and to seek opinions as a matter of law from the City Attorney, which City Attorney is authorized to furnish on behalf of the City, and opinions of law from such other attorneys for all documents contemplated hereby as required by law. The City's representatives or designees are in all respects authorized, individually and collectively, on behalf of the City to supply all information pertaining to the City as purchaser under the Contract Amendment for use in the Official Statement and the transactions contemplated by the Instruments or the Official Statement. The City Manager, the City Clerk and the Chief Financial Officer of the City or their respective designees are hereby authorized, empowered and directed, individually and collectively, to do any and all other acts and to execute any and all other documents, which they, in their discretion, deem necessary or appropriate to consummate the transactions contemplated by the Instruments or the Official Statement or as they deem necessary or appropriate to implement and carry out the intent and purposes of this Resolution.

Section 9. Severability. If any section, phrase or provision of this Resolution is for any reason declared to be invalid, such declaration shall not affect the validity of the remainder of the sections, phrases or provisions of this Resolution.

Section 10. Repealer. All motions, orders, resolutions and parts thereof in conflict with this Resolution are hereby repealed.

Section 11. Effective Date. This Resolution is effective on the date of its adoption.

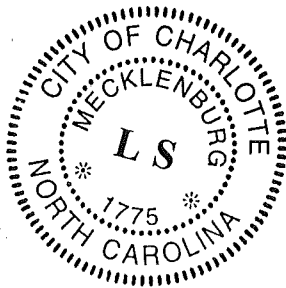

A RESOLUTION AUTHORIZING THE SALE OF REAL PROPERTY LOCATED AT 2333 NEWBERRY STREET.

WHEREAS, Charlotte Douglas International Airport ("Airport") acquired residential property more particularly identified as being Tax Parcel Numbers 115-133-04 and 115-133-05 and located at 2333 Newberry Street in Charlotte, Mecklenburg County, North Carolina (the "Property") in accordance with the FAR Part 150 Plan. The Property was acquired voluntarily and the owners were not under the threat of condemnation;

WHEREAS, in accordance with the Airport's FAA approved Re-Use Plan, the Property has been identified to be resold and the funds refunded to the Part 150 program;

WHEREAS, an offer was received to purchase the Property in the amount of \$42,000 subject to an aviation easement;

WHEREAS, the Property, zoned I2 and being sold for commercial use, was appraised at \$42,000 by Jack Morgan, a MAI appraiser, on December 3, 2012;

WHEREAS, in accordance with North Carolina General Statute 160A-269 the offer was advertised for ten days in the legal section of the Charlotte Observer on February 26, 2013 and no upset bids were received; and

NOW, THEREFORE, BE IT RESOLVED by the City Council for the City of Charlotte, that:

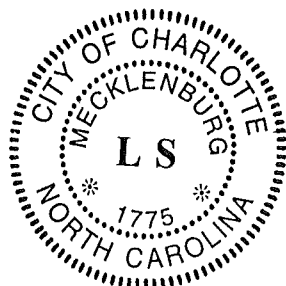
Sale of the Property for \$42,000 is authorized; and

WHEREAS, the Utility Department has programmed funding for said Water and Sewer Construction under Project P 5208H; and,

WHEREAS, under the proposed Agreement and subject to the Agreement provisions, the Municipality shall reimburse the Department for actual construction costs at the conclusion of the project.

NOW, THEREFORE, BE IT RESOLVED that the Municipal Agreement between the North Carolina Department of Transportation and the City of Charlotte Department of Transportation, is hereby formally approved by the City Council of the City of Charlotte and the Director of Transportation and Clerk of this Municipality are hereby empowered to sign and execute the Agreement with the Department of Transportation.

Whereas, the City Manager has recommended that the property listed on the attached Exhibit A be declared as surplus and sold at public auction; now therefore,

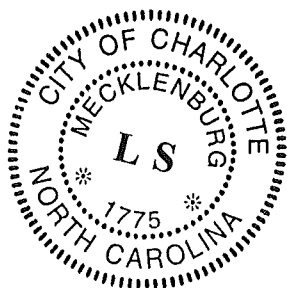
