


ORDINANCE NO. 5296-X O-50

AN ORDINANCE TO AMEND ORDINANCE NUMBER 5127-X, THE 2013-2014 BUDGET ORDINANCE PROVIDING AN APPROPRIATION FOR A SIDEWALK ON PROVIDENCE ROAD BETWEEN PROVIDENCE VILLAGE LANE AND AND EAST BARDEN ROAD

BE IT ORDAINED, by the City Council of the City of Charlotte;

- Section 1. That the sum of \$750,000 is hereby estimated to be available from a Federal Highway Administration Congestion Mitigation Air Quality grant through the North Carolina Department of Transportation
- Section 2. That the sum of \$750,000 is hereby appropriated in the General Capital Investment Fund (2010) to the Providence Road Sidewalk Project (0331028).
- Section 3. That the existence of this project may extend beyond the end of the fiscal year. Therefore, this ordinance will remain in effect for the duration of the project and funds are to be carried forward to subsequent fiscal years until all funds are expended or the project is officially closed.
- Section 4. All ordinances in conflict with this ordinance are hereby repealed.
- Section 5. This ordinance shall be effective upon adoption.



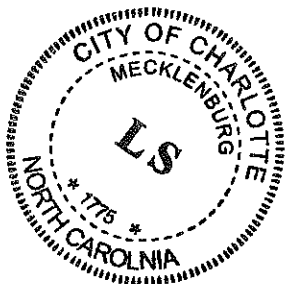



- Section 2. That the sum of \$1,386,000 is hereby appropriated in the General Capital Investment Fund (2010) to the Sunset Road SW Project (0331004)
- Section 3. That the existence of this project may extend beyond the end of the fiscal year. Therefore, this ordinance will remain in effect for the duration of the project and funds are to be carried forward to subsequent fiscal years until all funds are expended or the project is officially closed.
- Section 4. All ordinances in conflict with this ordinance are hereby repealed.
