AN ORDINANCE TO AMEND ORDINANCE NUMBER 9574-X, THE 2019-2020 BUDGET ORDINANCE PROVIDING AN APPROPRIATION OF \$5,696,778 IN FUNDS FROM THE CORONAVIRUS AID, RELIEF AND ECONOMIC SECURITY ACT

BE IT ORDAINED, by the City Council of the City of Charlotte;

Section 1. That the sum of \$5,696,778 is hereby estimated to be available from the United States Department of Housing and Urban Development from the following sources:

Community Development Block Grant: \$3,514,923
Emergency Solutions Grant: \$1,765,572
Housing Opportunities for Persons with Aids: \$416,283

Section 2. That the sum of \$5,696,778 is hereby appropriated in the COVID Stimulus Fund (2698) into the following projects:






