

**BE IT ORDAINED**, by the City Council of the City of Charlotte;

- Section 1. That the sum of \$74,470,000 is hereby estimated to be available from the Coronavirus Local Fiscal Recovery Fund provided by the American Rescue Plan Act of 2021.
- Section 2. That the sum of \$74,470,000 is hereby appropriated in the General COVID-19 Assistance Fund (2698).
- Section 3. That the existence of these projects may extend beyond the end of the fiscal year. Therefore, this ordinance will remain in effect for the duration of the projects and funds are to be carried forward to subsequent fiscal years until all funds are expended or the projects are officially closed.
- Section 4. That all ordinances in conflict with this ordinance are hereby repealed.
- Section 5. That this ordinance shall be effective upon adoption.

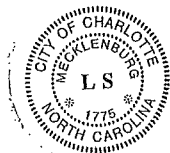

Section 2. That the sum of \$25,000 is hereby appropriated in the General Capital Investment Fund (4001) (if applicable) into the following project:


