AN ORDINANCE TO AMEND ORDINANCE NUMBER 548-X, THE 2023-2024 BUDGET ORDINANCE, PROVIDING AN APPROPRIATION OF \$235,000,000 FOR THE PURPOSE OF REFUNDING THE SERIES 2021B GENERAL OBLIGATION BOND ANTICIPATION NOTES AND 2013B GENERAL OBLIGATION BONDS.

BE IT ORDAINED, by the City Council of the City of Charlotte:

Section 1. That the sum of \$235,000,000 is hereby estimated to be available from the following source(s):

Proceeds from Refunding General Obligation Bond Issuance

Section 2. That the sum of \$235,000,000 is hereby appropriated in the Municipal Debt Service Fund (3000)

Section 3. That the existence of this project may extend beyond the end of the fiscal year. Therefore, this ordinance will remain in effect for the duration of the project and funds are to be carried forward to subsequent fiscal years until all funds are expended or the project is officially closed.

Section 4. That all ordinances in conflict with this ordinance are hereby repealed.

Section 5. That this ordinance shall be effective upon adoption.



ORDINANCE

AN ORDINANCE ORDERING THE DEMOLITION AND REMOVAL OF THE ACCESSORY STRUCTURE AT 940 AILEEN CR PURSUANT TO THE HOUSING CODE OF THE CITY OF CHARLOTTE AND ARTICLE 19, PART 6, CHAPTER 160A OF THE GENERAL STATUTES OF NORTH CAROLINA, SAID STRUCTURE BEING THE PROPERTY OF ISAAC W. WASHINGTON AND WIFE MARGARET MASSEY WASHINGTON 940 AILEEN CR PINEVILLE, NC 28134

WHEREAS, the accessory structure located at 940 Aileen Cr in the City of Charlotte has been found by the Code Enforcement Official of the City of Charlotte to be in violation of the Housing Code of the City of Charlotte and the owners thereof have been ordered to demolish and remove said structure(s); and

WHEREAS, said owner(s) have failed to comply in a timely fashion.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina, that the Code Enforcement Official of the City of Charlotte is hereby ordered to cause the demolition and removal of the accessory structure located at 940 Aileen Cr in the City of Charlotte in accordance with the Housing Code of the City of Charlotte. 
