

 Create land acquisition priorities that address gaps in underresourced communities and keep ahead of development.


#### **Accounting for Growth**

#### **Restoring and Protecting Ecology**


 Enhance the greenway network, designate new parkland reserves, and procure open space.



- Anticipate longer times to close on these properties unless they happen to be on the market



## Land Acquisition Other Updates

- Conservation and Preservation Plan
  - Long-term protection for land purchased as public open space

#### Funding

- Currently determined on an annual basis
- Uniform funding over the next five years
- Costs of securing, demolition, and upkeep until developed



- Similarities with higher ranked unfunded projects
  - Take advantage of partnerships
  - Expand existing parks with new phase of development
  - Tie parks into greenway trail system
  - Activate new parks
  - Address demand and geographic distribution
