### OFFICIAL COMMUNITY MEETING REPORT

### Petitioner: SunCap Property Group, LLC

Rezoning Petition No. 2022-037

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning, Design and Development Staff pursuant to the provisions of the City of Charlotte Zoning Ordinance.

### PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed written notice of the date, time and virtual format for the Community Meeting to the individuals and organizations set out on <u>Exhibit A</u> attached hereto by depositing such notice in the U.S. mail on July 27, 2022. A copy of the written notice is attached hereto as <u>Exhibit B</u>.

### DATE, TIME AND FORMAT OF MEETING:

The Virtual Community Meeting was held on Tuesday, August 9<sup>th</sup> at 5:30 p.m. via the Zoom platform.

Recipients of the notice letter were directed to RSVP for a link to the virtual meeting via email or phone to a member of the Petitioner's team. Members of the community who were unable to access the virtual meeting were directed to email or call a member of the Petitioner's team and could be provided with a copy (including a mailed paper copy, if necessary) of the meeting presentation. No hard copies of the presentation were requested in advance of the meeting.

### **MEETING PARTICIPATION:**

The Virtual Community Meeting had seventy-eight (78) total attendees at the start of the meeting, as listed in <u>Exhibit C</u>. The Petitioner was represented at the Community Meeting by David Lee, Fred Bolt, and Chandler Turner, as well as by Petitioner's agents Nate Doolittle with LandDesign, Stephen Overcash and Brian Simpson with ODA Architecture, and Collin Brown and Brittany Lins with Alexander Ricks PLLC.

### SUMMARY OF PRESENTATION/DISCUSSION:

Mr. Collin Brown welcomed the attendees and introduced the Petitioner's team, using a PowerPoint presentation, attached hereto as <a href="Exhibit D">Exhibit D</a>. Mr. Brown showed aerials and street views of the approximately 1.64-acre site located at the northeast intersection of East Boulevard and Scott Avenue, east of Kenilworth Avenue. He recognized that this is a prominent Dilworth intersection and expects for robust discussions to continue with the community throughout the rezoning process. He noted that an updated version of the rezoning request will include two additional parcels to the north so a second community meeting will be held in the future to officially incorporate those parcels into the rezoning request.

Mr. Brown explained that there are often many competing considerations that a developer must take into account, including transportation requirements, environmental constraints, council priorities, and community feedback. He stated that this property is currently zoned to a mix of the B-1, NS, and O-2 zoning districts. The recently-adopted 2040 Policy Map recommends the Neighborhood Center placetype for a mixture of pedestrian-friendly uses. Mr. Brown stated that the Petitioner's team believes the proposed uses are generally consistent with the policy recommendation.

The Petitioner is proposing a rezoning to the MUDD-O (mixed use – optional) zoning district with a site-specific rezoning plan for up to 20,000 square feet of office uses, 300 multi-family residential units, and 15,000 square feet of ground-floor retail, restaurant, and personal service uses. The Petitioner hopes to

include Starbucks in the redevelopment project as the corner ground-floor retail tenant. Originally the Petitioner was requesting an accessory drive-through for the Starbucks but will be removing the drive-through request based on feedback from Planning Staff and preliminary community discussions. The rezoning plan shows the proposed access points on East Boulevard and Scott Avenue and existing alley through the site. The request is for a maximum height of ninety-two (92) feet. For reference, the recent rezoning at the southwest of the East Boulevard and Scott Avenue intersection was approved for a maximum building height of eighty-five (85) feet. The existing alleyway connecting to the adjacent Twin Oaks Shopping Center (which contains the restaurant Fern) would be maintained and improved to twenty-two feet wide to create a better and safer condition for access. The alleyway serves to break up the massing of the two proposed building along Scott Avenue. The building would contain a structured parking deck that is wrapped with ground-floor retail along East Boulevard and residential units along Scott Avenue. Access from East Boulevard into the site would be restricted to right-in/right-out movement only. Tree save areas are shown on the parcel adjacent to Fountain View and along the northern portion of the site, closest to existing single-family residential homes, to serve as a transition and buffer to the neighborhood.

The Petitioner's architecture team introduced several example elevations from both the East Boulevard and Scott Avenue frontages as well as an emphasis on the pedestrian ground floor. Mr. Stephen Overcash described the architectural style as a contemporary building with traditional elements and ground floor commercial area design like "Dilworth's front porch." The majority of the proposed residential units would also have usable porches that are designed to be at least eight (8) feet deep to function as a true extension of living space for use and entertaining. Several other elements were incorporated into the design to blend with the character of Dilworth, including a large amount of brick façade and white building materials that relate to the historic building materials of surrounding residences, window proportions, heavy brick columns, and simple calming architecture. He explained that a lot of focus is going into the pedestrian experience with corner benches and planters to serve as a gathering area and flickering gas lanterns to give a more historic feel to the new-construction building.

Mr. Brown concluded the presentation by explaining the rezoning timeline which will include a second community meeting in the coming months and could result in a public hearing in October and decision in November, at the earliest, but more time may be needed to continue coordinating with the neighborhood. Mr. Brown stated that the Petitioner's team has been working for several months with the Dilworth Community Association (DCA) who can serve as a resource to neighbors. The virtual meeting was then opened for discussion via the "chat box" function and "raise hand" function on Zoom:

Several neighbors expressed concern over the proposed building height and context within the Dilworth neighborhood. Requests were also made to include height transitions along Fountain View and Scott Avenue to make it more contextually appropriate with existing adjacent single-family homes. The Petitioner's team stated that they would limit the number of stories along East Boulevard to a maximum of five (5) stories of residential uses and the 92' height request was due to the building design with subterranean parking before the site's grading is finalized. The retail is proposed to have higher than average floor-to-floor dimensions to create a significant pedestrian experience and elevated retail quality and the residential units are proposed to have eleven (11) feet floor-to-ceiling for a high-quality design, thus adding to the building height request as compared to a more standard nine-foot ceiling height for residential units. The majority of the height would be concentrated at the corner of East Boulevard and Scott Avenue with the roofline remaining level even though the grade increases approximately fourteen (14) feet along Scott Avenue (thus making the building appear shorter from the Scott Avenue side)

Neighbors also expressed concern over the added traffic, especially along existing and adjacent alleyways. Residents of the adjacent condo building stated that they did not want an increase of cut-through traffic

from this development. The Petitioner's team confirmed that they would install traffic measures such as a concrete barrier to restrict the Scott Avenue access to right-in/right-out only and prohibit cross movement onto the adjacent alley on the opposite side of Scott Avenue. For neighbors on Fountain View, they will be able to use the improved alley through the rezoning site to access Scott Avenue without having to go out to the more heavily traveled intersection with East Boulevard.

In response to an attendees request for adequate bike parking and usable bike racks, the Petitioner's team stated that they would be providing both long-term and short-term bike facilities.

A neighbor asked about the proposed amount of parking. In response, the Petitioner's team stated that there would be reserved parking for the retail uses and then a minimum of one parking space per bedroom for the residential units, which exceeds the Zoning Ordinance standards for residential parking, so they view the project as adequately self-parked so as to not have parking spill over into the adjacent streets. In response to follow-up questions, the Petitioner's team stated that they currently do not intend to charge a fee for parking in the deck and there would be a gate or controlled access for reserved resident parking above the retail parking.

In response to an attendee's question regarding construction timeline, the Petitioner's team stated that the project would likely take approximately two (2) years to build, so if the rezoning is approved in early 2023, they would expect construction to be completed in 2025. In response to construction access concerns, the Petitioner's team stated that they have not completed sequencing or staging studies yet but are working with contractors to limit the amount of time for road closures as they recognize the importance of the intersection.

A neighbor requested to see an elevation of the rear of the building. The Petitioner's team responded that they would have that image prepared for the follow-up community meeting.

Some attendees commented that they believed the proposed architecture was too modern or reminded them of South End. Others stated that they liked the proposed architecture. An attendee commented that architecture similar to Tranquil Court on Selwyn Avenue would be an appropriate traditional appearance.

In response to a concern regarding an increase to impervious area, the Petitioner's team stated that the site is already mostly impervious with a surface parking lot and building rooftops that were built on the site prior to the current stormwater ordinance controls so the proposed project would have updated stormwater controls that should be better than the current condition. In addition, the Petitioner's team would be adding tree save areas and supplemental plantings in several areas on the site.

Some neighbors commented that they would like to see some affordable housing units offered as part of the development while others stated that they did not want affordable units to be incorporated.

The property owner of the adjacent Twin Oaks Shopping Center commented that she appreciated the proposed improvements to the existing alley and would like a consideration of a traffic signal at the Fountain View intersection.

In response to questions about the sidewalk and pedestrian experience along East Boulevard, the Petitioner's team stated that the current proposal is for a minimum eight (8) foot wide sidewalk but with the potential of additional hardscape for a total sixteen (16) foot amenity zone with hardscaped materials and trees in grates. The Petitioner's team is studying the addition of a bike lane along the site's East Boulevard frontage.

An attendee commented that they agree the drive-through request should be removed. The Petitioner's team confirmed that no drive-through would be permitted on the site in the next iteration of the rezoning plan.

Per a neighbor's request for trash to be handled internally, the Petitioner's team confirmed that the plan was for trash and recycling to be stored internal to the building.

An attendee asked about the types of trees proposed for the streetscape and tree save areas. The Petitioner's team stated that for the streetscape along East Boulevard the trees would be spaced out approximately 40 feet with large maturing trees. Small maturing trees would be planted 30 feet apart along the Scott Avenue frontage due to the existing overhead powerlines. For the tree save areas, the Petitioner would preserve all existing trees deemed healthy by a third party and city arborist and then would supplement with new trees at a rate of 36 trees per acre. The redevelopment would likely have more trees once fully built out than the existing condition.

In response to a request for electric vehicle charging stalls, the Petitioner's team stated that they do install EV charging stations in all of their projects.

Per an attendee's request to describe the parking deck circulation, the Petitioner's team explained that the parking deck would be hidden behind the retail along the East Boulevard frontage and then ramps down to additional levels of parking at subterranean levels and below the alleyway.

The Petitioner responded in the affirmative to a question of whether the residential units would be able to convert to condominium units if market conditions change to make ownership preferred over rental units.

An attendee asked if the proposed porches/balconies for residential units would also be offered along the back side and Fountain View side of the building in addition to the Scott Avenue and East Boulevard frontages. The Petitioner's team confirmed that balconies are being proposed for all four sides of the building.

In response to a question regarding availability for rooftop green space or solar panels, the Petitioner's team stated that would likely be difficult for this project but that they would look into it.

In response to a request to bury the existing powerlines along the Scott Avenue frontage, the Petitioner's team stated that they would be willing to do so but Duke Power will not allow it for a development of this size on just a portion of the block.

The meeting concluded at approximately 7:30 p.m. with a confirmation that a second meeting would be held with the community.
