This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on <u>Exhibit A</u> attached hereto by depositing such notice in the U.S. mail on (April 21, 2023). The Community Meeting was held on May 4, 2023 at 6:00 PM at 626 Char Meck Lane, Charlotte, NC 28205.

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit C. The Petitioner was at the Community Meeting.

The Petitioner, Vinroy Reid, welcomed the attendees. The Petitioner proposed to rezone an approximately .874 site located at 626 Char Meck Lane, Charlotte, NC 28205 from the R5,O2 to B2 Conditional. The Petitioner explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

The Petitioner presented the site plan. The Petitioner showed proposed architectural elevations and discussed the design of the proposed facility. He used the elevations and renderings to explain the facility's design concepts, and operations.

One individual was concerned about the light at the end of the street. The Petitioner let them know that that the light is on a state road so unable to implement a change. The Petitioner stated that it may take a community effort.

One individual stated that they were concerned about a future mechanic shop, gas station or a junk yard. Petitioner stated that that was already listed as part of the conditional B2.
