COMMUNITY MEETING REPORT SECOND COMMUNITY MEETING

Petitioner: Red Cedar Capital Partners LLC Rezoning Petition No. 2022-191

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on <u>Exhibit A</u> attached hereto by depositing such notice in the U.S. mail on or before May 6, 2023. DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on May 17, 2023 from 6:00 pm until 7:00pm as a virtual meeting.

PERSONS IN ATTENDANCE AT MEETING (see attached conv of sign-in sheet):

The community meeting was attended by the individuals identified on the attached sign-in sheet, <u>Exhibit C</u>, and by Petitioner's development team: Russell Fergusson, Kory Hedrick, and Heather Smith.

SUMMARY OF PRESENTATION/DISCUSSION:

Russell Fergusson, Petitioner's Agent presented the basic components of the rezoning proposal, went through a presentation and the invited an open discussion with the two neighborhood attendees. The presentation covered the general nature of the rezoning petition, important rezoning process dates and petitioner's pending revisions to the proposed site plan.

This second meeting was attended by a different group of neighbors. Petitioner's team explained the layout of the single-family attached housing and the plans to address stormwater control and tree save. Emphasis was placed on the tree save and landscaping buffer surrounding the development. One neighbor asked several follow-up questions and expressed interest in retaining as many existing trees but also planting appropriately. The petitioner explained the likelihood that the areas required for stormwater retention will require some removal of trees and the group discussed the stormwater for the site and petitioner's commitments. The neighbors inquired about whether the residential units were intended to be at market rates and in particular inquired about whether it would have a homeowners' association to prevent corporate ownership and potential blight. Petitioner explained that it would be market rates and the attendees expressed that that was their preference. Petitioner explained the general HOA process. The attendees expressed general contentment with the proposal and indicated that they would speak with other neighbors.

Petitioner encouraged participants to reach out with any questions and comments in the future.
