COMMUNITY MEETING REPORT FOR REZONING PETITION NO. 2022-210

Petitioner: RRPVI SEBP CHARLOTTE, LP

Rezoning Petition No.: 2022-210

Property: ± 45.67 -acre site located on Clanton Road

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning, Design and Development Department pursuant to 6.203 of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATES AND EXPLANATIONS OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and details of the Virtual Community Meeting to the individuals and organizations set out on **Exhibit A** by depositing the Community Meeting Notice in the U.S. mail on 7/11/2023. A copy of the written notice is attached as **Exhibit B**.

TIME AND DATE OF MEETING:

The Community Meeting required by the Ordinance was held virtually on Tuesday, July 25, 2023, at 6:00 PM.

PERSONS IN ATTENDANCE AT MEETING:

The Petitioner's representatives at the required Community Meeting were Rachel Russell Krenz and Carson Grill with RRPVI SEBP CHARLOTTE, LP and Nate Doolittle with LandDesign. Also in attendance was Bridget Grant with Moore & Van Allen, PLLC.

SUMMARY OF ISSUES DISCUSSED AT MEETING:

I. Overview of Petitioner's Presentation.

Introduction and Overview of Development Plan.

Ms. Grant started the meeting by welcoming participants and thanking them for attending the community meeting for Rezoning Petition No. 2022-210. She then explained how the meeting would proceed and reviewed the agenda.

Ms. Grant explained the project includes ±45.674 acres located on Clanton Road and S I-77 Highway, west of South Tryon Street and south of Remount Road. Ms. Grant showed the site location identifying the parcels to be rezoned. The site is zoned B-D, B-1 and B-2(CD) and the requested zoning is TOD-CC(EX). Ms. Grant reviewed the Charlotte 2040 Place Type Map indicating a Manufacturing and Logistics place type. The proposed site plan was then displayed showing access points, rights-of-way, connectors and public streets throughout the development.

Ms. Grant explained the purpose of the rezoning and the EX-flexibility. The rezoning does not change permitted uses or heights. The development is being rezoned to: allow teaser parking on limited parcels, accommodate temporary parking as the site develops over time, provide flexibility in street design for the purpose of creating activated retail streets and preserving existing trees, clarify design standards for retail anchors, and to allow a unified approach to open space and tree save areas.

Ms. Krenz stated the development vision is to allow for a multi-phase development that leverages the central location and convenient access with a mix of uses in a walkable destination for all to enjoy. She explained that they would like to see retail, multi-family, office and hotel, so it's a mix of uses. Phase 1 will likely not include office and hotel, given the economic market today but hope to include it as soon as feasible. It is not planned to be an industrial center or single-family area but a dense, walkable neighborhood. The traffic study is in process. Early conceptual master planning has been conducted and they hope to refine phase 1 scope in the near future. Retail leasing conversations were started early to assess the viability of the site being a retail destination. Feedback has been strong with potential tenants. It is an amazing opportunity from an access standpoint.

Ms. Grant reviewed the proposed rezoning schedule with a proposed public hearing on November 20th, 2023, zoning committee on December 5th, 2023, and city council decision on December 18th, 2023. She explained that this can change with staff comments and with the timing of the traffic study.

Ms. Grant then opened the meeting for questions and answers.

II. Summary of Questions/Comments and Responses:

The participant's questions centered around uses and phases at the site. Ms. Krenz responded that they are trying to make a first phase include at least multifamily, retail and open space; creating a loved place from day one. She said they don't have any idea of the timeframe for the total site completion. She explained that the team is seeking public support for public infrastructure improvements.

There being no further questions, Ms. Grant thanked everyone for their participation.

CHANGES MADE TO PETITION AS A RESULT OF THE MEETING:

The development team will continue to coordinate efforts with City Staff.


