

General Provisions:

These Development Standards form part of the Rezoning Plan associated with the Rezoning Petition filed by Red Cedar Capital Partners, LLC (the "Petitioner") to accommodate the development of a residential community on an particularly depicted on the Rezoning Plan (the "Site"). The Site is comprised of a two parcels identified as tax parcel numbers 10814373 and 10814375.

A minimum of two (2) parking spaces per residential unit on site as generally depicted on the site plan, however, additional parking may be provided. A Right-of-Way Encroachment Agreement is required for the installation of any non-standard item(s) (irrigation systems, decorative concrete pavement, brick pavers, etc.) within a proposed/existing City-maintained str (homeowner's/business association. An encroachment agreement must be approved by CDOT prior to construction/installation. Petitioner shall dedicate forty (40) feet of right-of-way from the Plott Road centerline as generally depicted on the Site Plan.

### Architectural and Design Standards:

In addition to design provisions contained within the district regulations of the Zoning Ordinance, the development of the site will be governed by the following provisions and standards produced by the Petitioner and single-family attached buildings on site shall be designed to provide architectural elements that follow the design provisions noted below.

- Maximum building height shall be a maximum of forty (40') feet in height as measured by the applicable Ordinance standards.
- To provide privacy, all residential entrances within 15 feet of the sidewalk shall be raised from the average sidewalk grade a minimum of eighteen (18) inches.

- d The maximum blank wall expanse shall be limited to fifteen (15) feet on all building levels.

Garage doors visible from public or private streets shall minimize the visual impact by providing additional architectural treatments of either translucent windows, placement of the garage door so that it is recesse a m over the garage door opening.

Walkways shall be provided to connect all residential entrances to sidewalks along public and private streets.

### Streetscape and Landscaping:

The Petitioner shall provide 8 ft planting strip and 6 ft sidewalks as generally shown on the site plan.

Petitioner shall comply with the City of Charlotte Tree Ordinance.

### **Environmental Features:**

The petitioner shall comply with the City of Charlotte Post Construction Ordinance.

The location, size, and type of storm water management systems depicted on the Rezoning Plan are subject to review and approval as part of the full development plan submittal and are not implicitly approved with th

storm water treatment requirements and natural site discharge points. 3) For adjoining parcels receiving storm water discharge the petitioner shall analyze the adequacy of the existing storm water conveyance on the adjoining parcels. ### Lighting:
