#### COMMUNITY MEETING REPORT FOR REZONING PETITION NO. 2023-060

Petitioner: Habitat for Humanity of the Charlotte Region

**Rezoning Petition No.:** 2023-060

Property: ±8.34 acres along Carya Pond Lane at Hickory Grove Rd.

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning, Design and Development Department pursuant to 6.203 of the City of Charlotte Zoning Ordinance.

# PERSONS AND ORGANIZATIONS CONTACTED WITH DATES AND EXPLANATIONS OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and details of the Virtual Community Meeting to the individuals and organizations set out on **Exhibit A** by depositing the Community Meeting Notice in the U.S. mail on 5/24/2023. A copy of the written notice is attached as **Exhibit B**.

### **TIME AND DATE OF MEETING:**

The Community Meeting required by the Ordinance was held virtually on Wednesday, June 7, 2023, at 6:00 PM.

### PERSONS IN ATTENDANCE AT MEETING:

The Petitioner's representatives at the required Community Meeting were Jennifer Morell and Bob Glusenkamp with Habitat and Liz Ward with Give Impact. Also in attendance was Bridget Grant with Moore & Van Allen, PLLC.

#### SUMMARY OF ISSUES DISCUSSED AT MEETING:

### I. Overview of Petitioner's Presentation.

### **Introduction and Overview of Development Plan.**

Ms. Grant started the meeting by welcoming participants and thanking them for attending the community meeting for Rezoning Petition No. 2023-060. She then explained how the meeting would proceed and reviewed the agenda.

Ms. Grant explained the project includes  $\pm 8.34$  acres located on the south side of Hickory Grove Road, east of North Sharon Amity Road and at the intersection of Shamrock Drive. Ms. Grant showed the site location identifying the parcels to be rezoned and the landmarks to the east and west. Ms. Grant reviewed the Charlotte 2040 Place Type Map indicating a Neighborhood 2 place type. The existing zoning is R-17MF(CD) and the proposed zoning is N2-B. She also explained the conventional zoning and how it aligns with the translation of N2-B zoning district.

Ms. Grant reviewed the proposed rezoning schedule with a proposed public hearing on June 20<sup>th</sup>, 2023, zoning committee on July 5<sup>th</sup>, 2023, and city council decision on July 17<sup>th</sup>, 2023. She explained that this can change with staff comments.

Ms. Grant then opened the meeting for questions and answers.

### **II.** Summary of Questions/Comments and Responses:

Participants questions centered around traffic and access to the site.

When asked about the amount of traffic increase, Ms. Grant answered that it will be determined when the final design for the site is determined. Someone asked about access to the site and it was stated that it would be via Carya Pond. They asked about an agreement with the HOA, and it was stated it was understood that there is an access easement, and they will coordinate with the HOA or management company. There will likely be an HOA or a management company associated with new development.

It was asked if this was a Habitat community. Ms. Grant stated that they are the development partner on the site, and they are seeking general rezoning that would allow anyone to develop the site under the N2-B conditions. When asked if this was going to happen or if they could vote, Ms. Grant explained that the site is currently zoned R-17MF(CD) for a conditional development. They are seeking a rezoning that would eliminate the older plan and replace it with more current zoning that also aligns with the Neighborhood 2 place type/future land use identified in the approved 2040 plan and map.

There being no further questions, Ms. Grant thanked everyone for their participation and indicated the presentation would be sent as follow-up.

### **CHANGES MADE TO PETITION AS A RESULT OF THE MEETING:**

The development team will continue to coordinate efforts with City Staff.


