SUMMARY OF PRESENTATION/DISCUSSION:

Example of minutes: The Petitioner's agent, Steven Imobersteg, welcomed the attendees and indicated that the Petitioner proposed to rezone an approximately .48 acres site "4347 Castleton Rd" from N1-A to N1-C. Steven explained the rezoning process in general and stated that the purpose of the meeting was to discuss the conventional rezoning request with no associated site plan and respond to questions and concerns from nearby residents and property owners.

The participants listened to everything and only one question was asked. The sole question was asking if the properties had to face Castleton Rd and Steven Imobersteg referenced section 4.3 "In the case of a lot abutting both a local or collector street and a parallel arterial street (through lot), buildings shall orient toward the local or collector street."


