### • Project Introduction

- Sharika Comfort gave an overview of the project and introduced the members of the WBNC to the community residents.
- Allison Merriman gave an overview of the rezoning process, including the background of the current zoning in place.
- Sharika Comfort announced that there will be a second meeting for those residents who couldn't attend this
  meeting.

### Questions from residents

- What is the timeline for the project?
  - Sharika Comfort: 1<sup>st</sup> quarter of 2024 project kick-off, 1<sup>st</sup> quarter of 2025 Market opening.
- Would the market be open 7 days a week?
  - Sharika Comfort: it's up for the Co-Op shareholders to decide.
- Parking capacity?
  - Allison Merriman: 15 parking spaces minimum, 60 parking spaces maximum based on 15,000 sf building per UDO requirements.
- Are there any unforeseen circumstances for the Rezoning process?
  - Allison Merriman: It's a conventional rezoning, so at this point, no obstacles anticipated.
- Is there any coordination with CATS on the bus stop location (preference to have the bus stop adjacent to the market entrance along West Blvd.)
  - Guy Cousins: the coordination with CATS will occur during the design process.
- Would Community members have priority in the hiring for the store jobs process?
  - Sharika Comfort: Yes. Funding is in place for the manager's salary for two years; two candidates are being considered. The Seeds of Change program will hopefully provide future employees.
- Concerns about the location of the parking lot preference not to locate in place of the garden.
  - Allison Merriman: parking will not be located in place of the existing community garden area.
- Preference for the farm/garden to run during construction.
  - Noted.
- Has the Capital drive started and what would be the opportunity for the fundraising from different parties and residents?
  - Guy Cousins: The campaign started pre-covid and has raised approximately \$5.5M so far. Investments from outside of the community are welcome however benefits will be available for those within the trade area only. The salary of the Co-Op General Manager is secured with funding for two years. The community shareholders will have a chance to buy one non-transferable share per household with a one-time payment of \$100. One share equals one vote. All information regarding shares will be publicly available. The Co-Op would be a for-profit organization with a small profit margin, but nevertheless, the profit will be invested back in the community. The member/owner campaign will start in October 2023. Shares may be donated for others in the community who may not be able to afford the investment.

- Community concerns about market inventory; there is not enough fresh produce from the farm/garden to supply the whole community.
  - Guy Cousins: The Co-Op market model was studied thoroughly, An ample supply of fresh produce will be available in the store, with the intent to obtain goods from "black and brown farmers" and other suppliers within and outside of the community. Rickey Hall presented the history of this area and noted that there has not been a grocery store in this area for over 40 years. Harris Teeter and Publix are not interested in locating here. The market has a 99-year lease on the property. This is intended to "not just be a market but a movement".
- Will this store sell alcohol and tobacco? Not being a full-service store may be an issue if trips to other stores is required to meet all needs.
  - Guy Cousins: it is the community's decision, but as of now alcohol and tobacco is excluded.
     The market is intended to promote a health initiative so people must be engaged to make their own decisions.
- o What type of community space will be included in the Co-op?
  - Guy Cousins: there will be community space included in the building to hold educational
    events, and a full kitchen to prepare hot food. Coworking space will be provided. The Coalition
    is looking for community input on events/classes to serve the area.
- o Will the building be of sufficient size to accommodate a market and community space?
  - Charlie Blanton: Yes. The size of the building is comparable with stores on South Boulevard and NoDa.
- o Have you started accepting donations?
  - Sharika Comfort: Fundraising will begin on October 7<sup>th</sup> during the Legacy Festival.
- o Will there be on-going community meetings?
  - Sharika Comfort: Yes.
