COMMUNITY MEETING REPORT

Petitioner: Sri Sri, LLC

Rezoning Petition No. 2023-113

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time, and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. mail on 01/12/2024. A copy of the written notice is attached hereto as Exhibit B.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Tuesday, February 6th 2024 at 06:00 PM at the Hampton Inn & Suites Arrowood on 9110 Southern Pine Blv., Charlotte, NC 28273.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet): The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit C. The Petitioner was represented at the Community Meeting by Parimal Thakor and Ironelys Jaquez Serrata.

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Parimal Thakor, welcomed the attendees and introduced the Petitioner's team. He indicated that the Petitioner proposed to rezone an approximately 1.137 Acres site (the "Site") located at 9054 Southern Blvd, Charlotte, NC 28273, from the ML-1 zoning district to CG (CD) zoning district. He explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

Parimal provided an overview of the current schedule of events relating to this zoning request as outlined in the PowerPoint presentation displayed on screen. He announced that the Public Hearing is tentatively scheduled for Monday, March 18 2024. He mentioned the Public Hearing would happen before the Zoning Committee and the City Council. He then provided the intended dates of both the Zoning Committee and the City Council.

He explained the zoning request. He expressed the Petitioner is requesting that the site be rezoned from ML-1 zoning district to CG (CD) zoning district. The CG (CD) zoning district is intended to implement the vision for the commercial place types. This commercial zoning district permits a wide range of commercial uses including office buildings, which is the intended use to be built on this site. Accompanied by visuals depicting the site's location and dimensions (approximately 1.137 Acres), Parimal then presented a closer view of the site and a map illustrating the surrounding zoning information.

Parimal continued by sharing a proposed layout for the site, highlighting potential placements for the office building, parking areas, and designated tree save area zones. Detailing the blueprint of the proposed development, he explained that the structure would consist of three stories and a parking lot that would be available for users. The subsequent slide showcased potential renderings and examples of the proposed building, offering attendees a visual representation of the project's aesthetics. He then opened the floor for questions from the attendees, but none were forthcoming. With no further inquiries, the meeting concluded shortly thereafter.
