#### **Community Meeting Report**

Petitioner: Charlote 212, LLC

Rezoning Petition No. 2023-123

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

#### PERONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time, and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. Mail on 10/24/2023. A copy of the written notice is attached hereto as Exhibit B.

#### DATE, TIME AND LOCATION OF MEETING:

The community meeting was held on November 8<sup>th</sup> at 6 PM EST online via Zoom.

#### PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as <u>Exhibit C.</u> The Petitioner was represented at the Community Meeting by Steven Sargent, John Lallas, and Silvian Popusoi.

#### **SUMMARY OF PRESENTATION/DISCUSSION:**

The Petitioner's agent, Steven Sargent, welcomed the attendees and introduced the Petitioner's team. Steven indicated the Petitioner proposed to rezone approximately 4.26 acres at 1408 and 1416 W Sugar Creek Rd, Charlotte NC from CG zoning to NC-2 zoning. Steven explained the purpose of the meeting was to discuss the rezoning request, the plan for the project and to respond to questions and concerns from nearby residents and property owners.

Steven provided background information about the Petition and the plan for the subject property, which is to convert it to multifamily using the existing structure by adding kitchenettes to all hotel rooms and turning them into studio apartments. Steven also went over projects of identical scope in other municipalities, sharing before and after photographs of the scope of work proposed as conducted at other sites. Steven explained the planned use and renovation scope of the property.

John Gouch of 1504 W Sugar Creek Rd asked to see the parcels involved in the request. This was clarified.

Council member Renee Johnson asked if the Petitioner had information about how many families were living at the subject properties. Steven stated he had received information that there are 29 children living at the Charlotte Speedway Inn, and that he had been in communication with the City of Charlotte about possible solutions for the families affected by the purchase, including outreach from case workers and the potential for them to remain at the site via phased construction.

John Gouch asked about the location of a future city water building or treatment facility. Steven stated he was aware that was a future plan for a piece of the parcel at 1408 W Sugar Creek Rd, and that his company would assume the process of negotiating with the city upon potential purchase of the property.

Council member Johnson clarified that the November 20<sup>th</sup> meeting would also allow for public comment on the re-zone.

Council member Johnson asked that the members of the community reach out to her with their feelings on the petition.
