*Air Quality Comments:* No Comments

*Ground Water Services Comments:* Groundwater & Wastewater Services records indicate contamination site(s) exist on or within 1,500 feet of the property included in the petition. An established Area of Regulated Groundwater Usage (ARGU) as defined by the Mecklenburg County Groundwater Well Regulations extends 1,500 feet around the contamination sites. In an ARGU where municipally supplied water is available water supply wells for potable water supply, irrigation or open loop geothermal systems may not be permitted or constructed on or

within 1,000 feet of contamination sites. Wells may be permitted with special construction and sampling requirements between 1,000 and 1,500 feet of contamination sites.

NCDEQ UST Section Incident 6951, Airport Automotive and Brownfields Project 21052-17-060 are documented on some of these parcels. Subsurface investigation permits and permits to install water supply wells have been issued for some of these properties. Monitoring wells and water supply wells are registered on some of these properties. If any monitoring wells or water supply wells are identified within the project boundary the petitioner should either protect the wells from damage by flagging and fencing during site development or permanently abandon the wells per the Mecklenburg County Groundwater Well Regulations prior to any demolition or grading activity occurring and conduct a survey to locate the monitoring wells. A current SIP from GWS is required for permanent well abandonments. The abandonments must be completed by a North Carolina Certified Well Contractor.

Information from property records does not indicate the use of oil, wood, or coal as a heating fuel at these properties, but based on the age of construction of structures on some of these properties, the properties may contain an underground or above ground fuel oil storage tank as potential heat sources. Any existing tanks and their contents should be removed, following applicable NCDEQ guidance, prior to any demolition or grading activity.

**MCAQ Scope of Review:**

Mecklenburg County Air Quality (MCAQ) has reviewed the petitions with regard to air quality regulations for stationary sources and demolition and/or renovation of structures (e.g. National

Emission Standards for Hazardous Air Pollutants for asbestos). Comments may also be made regarding incompatible land uses, sources of Toxic Air Pollutants, proximity to Risk Management Plan facilities, and proximity to known nuisance conditions or sensitive populations. MCAQ has conducted the review based on information submitted by the petitioner, review of aerial photographs (as available through the Mecklenburg County Polaris system), review of the "Air Pollution Facility Information Online" database available from the MCAQ website, and review of Mecklenburg County Health Department records. The review is cursory based on limited information provided within petition applications and site plans.
