COMMUNITY MEETING REPORT

Petitioners: 410SG Partners, LLC & Savona II, LLC

Rezoning Petition No. 2024-113

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte's Zoning Ordinance.

A representative of the Petitioners mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. Mail on July 15th, 2025. A copy of the written notice is attached hereto as Exhibit B.

The Community Meeting was held on Tuesday, July 29th, at 6:00PM at 411 S. Gardner Ave., Charlotte, NC 28208.

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as <u>Exhibit C</u>. The Petitioner was represented at the Community Meeting by the following individuals:

Greg Pappanastos – Argos Real Estate Advisors Michael Dunning – MEND Architecture

The Petitioner welcomed the attendees and introduced the Peitioners' team. The Petitioner gave a presentation of the existing site, development to date, and the proposed rezoning of the approximately 3-acre combined sites at 410 S. Gardner Ave. and 401 S. Gardner Ave. (collectively "the Site") from ML-2 and MUDD(O) to the Innovation Mixed Use (IMU) district. The Petitioner gave a history of the Site and previous rezonings, shared information about the intended tenant uses at the Site and received and answered questions regarding the Site from residents and property owners.

The Petitioner provided background information on the Petitioner's experience and its business focus. The Petitioner and the Petitioner's architect both discussed key elements of the Site plan and intent of development, sharing details about potential tenants and uses throughout the Site under the new proposed zoning district.

Upon the Petitioner's request, residents and property owners asked questions and made suggestions as to uses they would like to see at the Site. The following questions and suggestions were noted by the Petitioner:

- (Question) With the Stewart Creek Greenway so close-by, will there be ample bike racks for cyclists on the Site? Could these bike racks incorporate art into their design, so they aren't so ugly?
 - (Answer) The zoning district requires a minimum number of bike racks and storage, and we will look at additional areas for bike storage and creative ways to deliver the solution.
- (Comment) The neighborhood needs a "watering hole" or cocktail bar for residents to congregate.
 - (Answer) We very much see food and beverage as an integral part of the Site.
 The market will ultimately determine how much office and retail will make up the project, but we are interested in attracting uses that serve the hyper-local community.
- (Comment) The neighborhood needs everyday services like coffee, grab-and-go food (ex Pasta & Provisions).
 - (Answer) Savona Mill expects to provide retail opportunities, including restaurants, bars and other food uses. We expect that there will be a number of quick serve options, once the mill and Site are fully stabilized.
- (Question) What kind of connectivity to the greenway is provided under the current plan?
 - (Answer) As part of the mill's redevelopment, we agreed to provide a private section of greenway on the east side of Stewart Creek in the larger previous master rezoning. Our project will include sidewalk that will eventually tie into Phase II of the Vera Apartments by Portman Residential. It is our hope that they will connect the private portion of the greenway via a future sidewalk along the Chamberlain Ave. side of their property, which will connect to the sidewalk we have already installed. We will look at providing wayfinding from the greenway to the Site. The Petitioner gave examples of well done greenway focused development projects, like Krog Street Market in Atlanta and the Swamp Rabbit Café & Grocery in Greenville, SC.
- (Question) Will the project tie into the history of the neighborhood(s)?
 - O (Answer) We conveyed the naming rights for "Savona" to the Portman Holdings partnership, when we contributed the mill into the partnership and sold the remaining land to Portman Residential. We are reviewing the history of the Site to see if tying to the history of the buildings on the Site will be of value. We like to do that whenever possible for optimum story-telling.
- (Comment) The neighborhood needs a full-service restaurant for families and a brunch spot.

 (Answer) As previously discussed, it is our intent to provide opportunities for food and beverage within the Site. We are sizing utility capacity (water, gas and electricity), as well as installing grease traps, to accommodate these types of uses in advance.
