	The Community Meeting was coordinated, scheduled, and offered to the public as provided by the City of Charlotte Unified Development Ordinance guidelines. Adjacent residents attended the petition community meeting as noted on the Attendance Log.
Purpose:	To present the Conditional Rezoning Petition 2024-004 to any neighboring residents or homeowners who were in the rezoning mailer radius or who spoke to the Petitioner or Petitioner's representatives and were invited. Urban Design Partners recorded the presentation to be publicly posted on our website for community benefit.

Minutes:	The following items were discussed in the presentation:
	Nolan began the meeting at 6:02pm by introducing himself and the petitioning team. The location of the petition was described as 5215 S Tryon Street, located south of South Tryon Street, east of Southampton Road, north of Shady Grove Lane, and west of Skipwith Place. Aerial imagery was displayed to familiarize attendees with the site as it exists today and provide surrounding context. Nolan provided background information on City zoning, the unified development ordinance, and long-range plans. He explained the purpose of the rezoning request and process in the city. Adjacent zoning districts were reviewed and used to show development trends in the area. The 2040 policy map place type was then described as Neighborhood 1. Nolan highlighted the place type description found in the

g, the the nd used described as Neighborhood 1. Nolan highlighted the place type description found in the 2040 plan and what it is envisioned to provide. The rezoning site plan and rendered site plan were displayed, showing up to 46 multifamily attached Townhome units. Nolan described features on the site such as green area, landscape yards, accessibility, driveways. He then described the conditions of approval related to architectural elements. The rezoning timeline was reviewed and Nolan shared his contact information in case attendees would like to follow up offline, after the meeting. A question-and-answer session followed the presentation.

Questions/Comments by Attendees:

1. How will cars get to the site from S. Tryon Street?

A: A Right-in right-out driveway access is proposed on the southern side of South Tryon Street. Vehicles traveling north will be able to enter the site via right turn movement. Vehicles traveling south will need to make a U-turn movement, where safe. Potentially at Southampton Road or farther down the street if necessary.

Having no further questions, Nolan thanked those in attendance, provided his contact information, and informed attendees how to access a recording of the meeting. The meeting adjourned at 6:22pm.
