#### COMMUNITY MEETING REPORT FOR REZONING PETITION NO. 2024-031

Petitioner: Panthers Stadium LLC

**Rezoning Petition No.:** 2024-031

Property: ±12.4 acres located at 325 S. Cedar Street, Charlotte

This Community Meeting Report is being filed with the City of Charlotte City Clerk and the Charlotte-Mecklenburg Planning, Design and Development Department pursuant to 6.203 of the City of Charlotte Zoning Ordinance.

# PERSONS AND ORGANIZATIONS CONTACTED WITH DATES AND EXPLANATIONS OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and details of the Virtual Community Meeting to the individuals and organizations set out on **Exhibit A** by depositing the Community Meeting Notice in the U.S. mail on 3/29/2024. To be inclusive to nearby residents, the list of recipients included additional residents of associations located across Cedar Street than those listed on the list received from the City. A copy of the written notice is attached as **Exhibit B**.

### **TIME AND DATE OF MEETING:**

The Community Meeting required by the Ordinance was held virtually on Wednesday, April 10, 2024, at 7:30 p.m.

#### **PERSONS IN ATTENDANCE AT MEETING:**

The Petitioner's representative at the required Community Meeting were Tamera Green with Tepper Sports & Entertainment/Panthers Stadium LLC, Adam McGuire and Nate Doolittle with Land Design, and Jeff Brown and Keith MacVean with Moore & Van Allen, PLLC.

#### SUMMARY OF ISSUES DISCUSSED AT MEETING:

### I. <u>Highlights of Petitioner's Presentation.</u>

Jeff Brown of Moore & Van Allen welcomed the participants and thanked them for attending the virtual meeting to hear about the rezoning plans for the Carolina Panthers practice facilities. Mr. Brown introduced Tamera Green, Chief Communications Officer for Tepper Sports & Entertainment, Nate Doolittle of Land Design, the project land planning and civil engineering firm, as well as Keith MacVean of Moore & Van Allen.

Mr. Brown explained the approach to the virtual meeting and the hope that the virtual nature of the meeting was helpful to some who may be out of town to allow virtual attendance. He mentioned that there were about 18 participants signed in virtually.

Mr. Brown indicated the overall nature of the rezoning is primarily to provide some adjustments to the current practice fields configurations and provide associated facilities located next to the rail-line and Cedar Street in Uptown. He then reviewed the agenda for the evening with a presentation addressing the overview purpose of the rezoning and reviewing the rezoning plans in more detail. This will be followed by questions by participants in the virtual chat feature.

Mr. Brown then reviewed the location and parcels that are being rezoned. It includes the same property on which the practice fields are located now near the stadium along with an additional piece that connects to 4<sup>th</sup> Street currently owned by CATS and used for parking and a small sliver piece currently owned by Johnson & Wales University. Mr. Brown reiterated that the rezoning is largely technical in nature to allow the field adjustments and for installation of a fieldhouse for the indoor practice field and related activities for football operations similar to the prior Atrium Health Dome as well as other possible uses in the future for the portion of the property on the CATS property a significant distance from Cedar Street along the rail-line.

Mr. Brown then introduced Tamera Green of Tepper Sports & Entertainment for some comments on the project rezoning. Ms. Green thanked folks for participating in the meeting and thanked a few residents from nearby with whom she had reached out previously as part of the Panthers' efforts to make nearby residents along Cedar Street area aware of the rezoning. Ms. Green mentioned as well that in many ways the rezoning simply enhances the practice facilities that have existed on the property for several years and permits the new field house along the common boundary with property of Johnson & Wales next door. This will serve essentially the same purpose of practice and periodic events as the previous primary focus at this time. Ms. Green emphasized that the plans are still evolving especially as to the future development areas.

Jeff Brown picked back up the presentation to review a history of the zoning of the property being rezoned. The fields portion was rezoned as part of the overall stadium rezoning back in the 1990s when the Panthers were first to Charlotte. Several years ago, the fields portion was rezoned to reconfigure the fields and add the Atrium Health Dome and related practice facilities, operations and events. He said the current rezoning is under the City's new Uniform Development Ordinance (UDO) and is to the Uptown Edge district, which is a district that is consistent with the community plan's designation for the current property.

Mr. Brown also mentioned that because of the unique nature of a building like the fieldhouse, some variations from the standards of the UE district under the UDO are sought to accommodate the field inside and similar aspects. These are not needed with more customary apartments or office buildings in the center city. Mr. Brown then introduced Nate Doolittle to review the rezoning in more detail.

Mr. Doolittle pointed to images of the rezoning plan that show the location of the fields and areas where building improvements and parking may be located. He mentioned the fields are shown in light gray and the fieldhouse location is shown in darker gray – along the boundary with Johnson & Wales University property next door. He noted that most of the frontage along Cedar Street will remain fields. He also discussed other portions of the property being rezoned as well as the access to the rezoning site which includes a potential new access by way of 4<sup>th</sup> Street. He noted the location of the limited/periodic access and fire lane from Cedar Street along the common boundary with JWU, and parking areas.

Mr. Doolittle referenced a slide with an illustrative site plan that specifies in more detail the fields and fieldhouse locations within Development Area A (i.e., the property on which the fields and Atrium Health Dome were located). He also noted the location of the CATS rail-line aspects. Mr. Doolittle indicated that the Development Area B (e.g. the CATS lot and JWU small parcel) has not been programmed and is shown for possible future development. It is anticipated that parking will remain on this portion for near term and could have other uses allowed under the Ordinance in this area, but that is subject to further consideration.

Mr. Doolittle mentioned that while still in the planning stages we are currently exploring a potential structure for the fieldhouse building within Development Area A of around 65-75 feet in height. Again, plans are not finalized but there will be window treatment and ambient light. It was noted that the rezoning

plan currently shows a 95-foot maximum height for Development Area A, but this is being re-evaluated. He mentioned generally other streetscape aspects and site plan matters.

Mr. Doolittle then returned the presentation to Jeff Brown, who opened things up to questions in the virtual chat feature and explained logistics for the question and response portion of the meeting. Mr. MacVean then assisted with lifting-up various questions for responses by the panelists.

#### **II.** Summary of Questions/Comments and Responses:

One questioner asked if there will be improved fencing design along Cedar St. instead of current tarp treatment. The design has not been detailed at this stage, but Petitioner will be mindful of this as the project moves forward.

The question was raised as to whether retail and food uses will be provided as part of the plan. The focus of the rezoning and development activities is the reconfiguration of the fields as well as the installation of the fieldhouse for the football practice and operations similar to the Atrium Health Dome, and catering and food service will be provided as a part of events and as part of the football operations activities.

Building Height along Cedar within Development Area A: one questioner asked if the portion of the fieldhouse along Cedar Street will affect the views of the city from residents across Cedar Street? It was explained that while still in the planning stages we are currently exploring a potential structure for the fieldhouse of around 65-75 feet in height, but the rezoning plan currently shows a 95-foot maximum height for Development Area A, which is under further review. It is difficult to determine how much views may be impacted at this time. It is noted that most of the Cedar Street frontage consists of outdoor field. Someone also asked how the fieldhouse compares to the Atrium Health Dome in height. The Atrium Health Dome is 65 feet as was clarified during the discussion.

Parking for Visitors: questions were asked about parking for visitors. It was explained that as with the current operations for the fields, the organization seeks to provide special care to parking. Parking will continue to be provided on the site being mindful of events like game day to ensure they continue to be properly handled. The parking needs for visitors associated with the fieldhouse were also asked and it was explained that there will be periodic events, but the principal operations will be for practice and sports operations. Parking may also be contemplated on Development Area B portion. One person inquired about ticketing of parkers on increased fines on large volume days to discourage parking on streets. It was noted that most of the practice activities involve foot traffic from the stadium area.

Mr. Doolittle indicated that access from Cedar St. along the boundary with JWU is required by emergency services and fire department to get the correct hose pull and maneuvering around the fieldhouse so that is the primary use of that connection although it may be used some in other limited instances for events and property maintenance.

What is the new construction deadline? We are still in the construction planning phase and so the process is very fluid, but first phase of the fields would be completed in the summer. The fieldhouse design will be continued, and it could be sometime in the next few years. There are no current plans for future development areas.

Traffic questions: in response to traffic questions, it was noted that strong coordination efforts will continue to take place to ensure proper support management by CMPD. A panelist added that they will continue to collaborate with CMPD to ensure the safety of pedestrians while limiting the amount of vehicular traffic in that area as has been done in the past.

A questioner asked about the location of the fieldhouse building proximity to Cedar Street. It was noted that there is a planting strip area, a sidewalk and then fencing, so there is a separation area; again, further review of exact dimensions is under way.

One resident asked about the remainder of the rezoning schedule. Mr. Brown stated that the city portal will have updates as we move forward, and residents can also reach out for updates. As to the rezoning schedule, the public hearing is planned for May 20<sup>th</sup>, the zoning committee would then be June 4<sup>th</sup> and the current schedule calls for a decision on June 17<sup>th</sup>.

In response to a question about adherence to the noise ordinance, it was stated that the ordinance will be followed.

One questioner asked if there will continue to be a sidewalk around the practice field. It was noted the currently contemplated sidewalk that goes around Johnson & Wales will not remain. But there is a plan to ensure a pedestrian connection from the tunnel to the Clutch parking lot that would then extend down the greenway to Erwin Creek; which is the approved County alignment for the greenway system to support the permanent location for multi-modal connectivity. It is understood that the existing sidewalk along Cedar St. along with a planting strip will remain.

Ms. Green thanked everyone for their participation. Mr. Doolittle added that some more detail on questions may be answered with our next submittal to the City. Mr. Brown also thanked everyone for their participation. We look forward to moving through the process.

There being no further questions, the community meeting was adjourned.

### CHANGES MADE TO PETITION AS A RESULT OF THE MEETING:

The development team will continue to coordinate efforts with City Staff and be mindful of the input received from the meeting and other discussions.


