COMMUNITY MEETING REPORT

Petitioner: Gethsemane Cemetery and Memorial Gardens

Rezoning Petition No. 2024-039

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning, Design and Development Department pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED: David W. Murray, a representative of the Petitioner, mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on **Exhibit A** attached hereto by depositing such notice in the U.S. mail on April 24-25, 2024. A copy of the written notice is attached hereto as **Exhibit B**.

DATE, TIME AND LOCATION OF MEETING: The Community Meeting was held virtually on Tuesday, May 7, 2024, at 6:00 p.m. Link: https://us02web.zoom.us/j/87032501995 A call-in number was also available.

PERSONS IN ATTENDANCE AT MEETING: The Community Meeting was attended by one (1) City Council Member and (2) community members as shown on the list attached hereto as **Exhibit C**. The Petitioners were represented at the Community Meeting by David W. Murray (agent and attorney for Petitioner), owner John B. Gouch, Sr., John B. Gouch, Jr., and Ken Andrews.

SUMMARY OF PRESENTATION/DISCUSSION: Mr. Murray prepared opening statements to introduce himself and the other representatives for the Petitioners. All people present for the virtual meeting stayed the entire meeting. A copy of the PowerPoint presentation is attached hereto as **Exhibit D**. The presentation began at approximately 6:10 p.m. and was complete at approximately 6:35 p.m. The Petitioners remained on the meeting until approximately 7:00 p.m. The Petitioners indicated that they proposed to rezone an approximately 10.654 acre site (the "Site") from N1-B to IC-1. The Petitioners explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and respond to questions and concerns from nearby residents and property owners. The Petitioners informed the attendees that the proposed use was for cemetery related purposes of the adjacent Gethsemane Cemetery. The Petitioners showed the attendees the area included in the rezoning, the 2040 Plan, and the adjacent rezoning plans. The Petitioners asked if the attendees had any comments about the proposed plan. The questions from Ms. McDonald centered on what uses would likely be made of the existing houses and the questions from Mr. Margolis centered on the build-out of the existing master-planned cemetery. There were no concerns expressed by any of the attendees.

The Petitioners gave the attendees the City's rezoning case number and deadlines so that they could know when to attend the public hearings or review the comments from staff online.





Adjacent Zoning - Legacy INST (CD)


Rezoned 1/22/1996


Rezoning 1995-089

Allows cemetery, crematorium, active adult facility, storage, etc.

Also requires buffers along residential zoned parcels.

Nothing about this rezoning will change the legacy INST (CD) zoning.






Existing Uses

•This site is currently used for office and single-family residential uses. Office uses are grandfathered.

Recommended 2040 Plan

- There is no small area plan for this property.
- Place Type map for 2040 plan calls for Neighborhood 1 residential type uses primarily because of existing uses.
- New UDO allows cemetery uses in Neighborhood 1 zoning; however, it doesn't allow the supportive office/institutional type uses of the existing structures and also requires buffers which limit the use of the subject properties since they're zoned N1-B.



Rezoning Sought - IC-1

- •Conventional rezonings do not require a site plan. They are limited to the uses allowed in the UDO and development standards.
- IC stands for Institutional/Campus.
- Purpose of this rezoning is to allow conformity of the existing structures and land to the adjacent INST (CD) rezoning. Allows more flexibility in future improvements and expansion of the cemetery.
- This is not a change to the existing master planned INST (CD) zoning.
- The intention is <u>not</u> to demolish the existing structures.
