

Approximately 1.21 acres located on the west side of Chamberlain Avenue, north of State Street, and south of Yellowstone Drive.



STAFF RECOMMENDATION	<ul> <li>Staff recommends approval of this petition.</li> <li><u>Plan Consistency</u></li> <li>The petition is <b>consistent</b> with the 2040 Policy Map recommendation for Innovation Mixed-Use.</li> <li><u>Rationale for Recommendation</u></li> <li>This zoning helps to contribute to Charlotte's economic viability by providing mixed-use urban places that include light manufacturing, office, residential, and retail.</li> <li>The buildings surrounding the sites include office development, light manufacturing, and multi-family residential which aligns with the IMU zoning.</li> <li>This area and the requested zoning are characterized by adaptively reused buildings and low to mid-rise single-use structures that are transitioning to vertically integrated uses in a pedestrian-oriented environment.</li> <li>This zoning encourages active and passive community gathering spaces.</li> </ul>

<ul> <li>The site could encourage adaptive reuse of light industrial or underutilized buildings, embracing unique history and form.</li> <li>The need for environmental justice within this area is a high priority according to the EGF Reports. The proposal to change from Manufacturing &amp; Logistics uses, which are typically more environmentally hazardous, to Innovation Mixed Use, which limits noxious uses, could help to support the need for environmental justice in this area.</li> <li>The petition could facilitate the following 2040 Comprehensive Plan Goals:</li> <li>8: Diverse &amp; Resilient Economic Opportunity</li> <li>9: Retain Our Identity &amp; Charm</li> </ul>

The properties to the north consist of single family residential, multi-family residential, and industrial developed properties. The subject property is marked with a red star.




The site is currently occupied by a structure.

### • TRANSPORTATION SUMMARY

- The site is located adjacent to Chamberlain Avenue, a City-maintained local street, west of Gardner Avenue, a City-maintained local street. A Comprehensive Transportation Review (CTR) is not necessary for the complete review of this petition due to the conventional rezoning. A CTR will be required during permitting if the site generates site trips over ordinance thresholds. The site will be subject to transportation improvements in accordance with the UDO and the adopted CDOT Streets Map. CDOT will work with the petitioner during the permitting process to pursue all options to provide additional forms of connectivity that reflect the types of development associated with this place type and zoning district.
