The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto <u>Exhibit C</u>. The Petitioner was represented at the Community Meeting by Jinwei Pan and Prad Lakshmipuram.

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's representative, Jinwei Pan, welcomed attendees and introduced the rezoning petition. Mr. Pan explained the proposal to rezone an approximately 2.58-acre site located at 13309 Zoar Rd from the current N1-A zoning district to the N1-C Neighborhood zoning district. The host explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

Prad Lakshmipuram provided additional context regarding the objectives of the rezoning, emphasizing the intent to develop a neighborhood-friendly environment under the N1-C zoning classification. A site plan was presented, showing the general concept of the proposed

development and highlighting key aspects such as density, layout, and neighborhood compatibility.

The representatives further discussed the rezoning process, potential impacts, and the advantages of the proposed development, including improved land utilization and enhanced neighborhood dynamics.

Attendees were invited to ask questions and raise concerns, which were addressed thoroughly by the Petitioner's representatives. The questions primarily focused on density, traffic impacts, community compatibility, and potential property value changes.
