This Community Meeting Report is being filed with the City of Charlotte City Clerk and the Charlotte-Mecklenburg Planning, Design and Development Department pursuant to 37.2 of the City of Charlotte Unified Development Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATES AND EXPLANATIONS OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and details of the Virtual Community Meeting to the individuals and organizations set out on **Exhibit A** by depositing the Community Meeting Notice in the U.S. mail on 9/16/2025. A copy of the written notice is attached as **Exhibit B**.

TIME AND DATE OF MEETING:

The Community Meeting required by the Ordinance was scheduled virtually on Tuesday, September 30, 2025, at 6:00 PM.

PERSONS IN ATTENDANCE AT MEETING:

The list of attendees from the required Community Meeting is attached as **Exhibit C**. The Petitioner's representatives were Troy Karski with DR Horton, Weston Boles with Ardurra, and Bridget Grant with Moore & Van Allen, PLLC.

SUMMARY OF ITEMS DISCUSSED AT MEETING:

I. Introduction and Overview of Development Plan.

Ms. Grant with Moore & Van Allen welcomed and thanked the participant for their interest in Rezoning Petition No. 2025-104 and introduced the other representatives of the Petitioner in attendance. Ms. Grant and the Petitioner's representatives then provided the following information during the presentation:

The 14.9-acre Site is located between Nations Ford Road and W. Hebron Street, north of Central Piedmont Community College (CPCC) campus, south of Arrowood Road. The site is zoned Business–Distribution, Conditional (BD(CD)), Office Flex Campus (OFC) and Institutional Campus, 1 (IC-1). Proposed zoning is N2-A — Neighborhood, 2 — A to allow development of the Site with a residential community. The Charlotte Future 2040 Plan place type for the site is Manufacturing and Logistics, and Campus. The Site is currently vacant and adjacent to some residential communities and the CPCC campus. Ms. Grant shared the proposed Site plan showing access points off Nations Ford Road and Old Hebron Road, with stubs for future connections, open space, stream buffers, the existing waterline easement and the residential building envelopes.

Ms. Grant explained the tentative rezoning schedule of a Public Hearing on November 17, 2025, Zoning Committee on December 2, 2025, and City Council Decision on December 15, 2025.

The Community Meeting was then opened for questions from the participant.

II. Summary of Questions/Comments and Responses:

The participant had no comments.

Ms. Grant concluded by thanking the participant for their engagement.

CHANGES MADE TO PETITION AS A RESULT OF THE MEETING:

No specific changes were made as a result of the Community Meeting. The development team continues to coordinate its efforts with City Staff.


