Easter's Home: A Snapshot

- Conversion of a 14,000 s.f. Christian Ed building
- Ground lease from Presbytery
- Creation of 21 studio apartments (permanent supportive)
 Supportive housing for chronically homeless
- Partners:
 - DreamKey for development
 - Roof Above for operations upon completion
- Location: 1.3-acre urban church campus in Elizabeth
- Historic, affluent, residential/commercial neighborhood

FAITH HOUSING

Pros of an Existing Building

- Preservation ("adaptive reuse")
- Environmental Impact
- Maintains integrity of campus look/feel
- CAN help avoid rezoning NIMBYISM/fight
- Neighborhood may more readily welcome vs a new structure



Cons of an Existing Building

- Complications get a good architect!
- May limit room design and shared space options
- Can be more expensive and take longer
- Can limit a re-imagining of a overall campus redesign

Myers Park United Methodist Grant	\$ 1,000,000
North Carolina Housing Finance Agency	\$ 600,000
Merancas Foundation Grant	\$ 500,000
City of Charlotte Housing Trust Fund Grant	\$ 630,000
American Rescue Plan/through Mecklenburg County	\$ <u>2,500.000</u>


Public / Private / Faith / Philanthropy

Other Considerations

- Get expertise involved asap
 - Housing and development professionals
 - Server Server
- Congregation should openly discuss:
 - Interaction/ministry to neighbors and impact on church function
 - Timeframe is often 5-10 years: Do you have the energy and capacity?
 - Is housing best and highest use of building or something else?
 - Develop the property now or plan (formally) to leave a legacy
