METROPOLITAN PUBLIC TRANSIT AUTHORITY

- Twelve appointments for a two-year partial term or four-year term beginning December 15, 2025* and ending on a date to be determined**.

 - Two recommended from Charlotte Regional Business Alliance
 - One recommended from Foundation For the Carolinas
 - One appointment must be an individual that has experience owning or operating a small business, and
 - At least one appointment for an active user of the current CATS system

** Initial terms of office shall commence upon approval by the Secretary of State of the articles of incorporation. December 15, 2025, is a tentative date.*

*** One-half of the initial appointments shall be for two-year terms, to be determined by lot at the first meeting of the board of trustees, except the initial term of one member appointed by the General Assembly shall be for two years and the initial term of the other member appointed by the General Assembly shall be four years to be determined by lot at the first meeting of the board of trustees. An initial term that is two years or less shall not be counted in determining the limitation on consecutive terms.*
