Required Documentation

- * Applicant must provide a current copy of the vehicle registration.
- * The address on the motor vehicle registration must be in the permit zone you are applying.
- * Address must also match the address on one of the following proofs of residency:
 - a) Driver's license
 - b) Copy of lease/deed **or**
 - c) Signed and notarized letter of proof of residence

Permit Fees/Conditions as of Fiscal Year 2025	
<i>Residential Permit Quantity</i>	One (1) permit per licensed driver, not to exceed six (6) total permits per household, inclusive of guest permits.
<i>Residential Permit Cost</i>	Permit #1: \$35.00 Permit #4: \$50.00 Permit #2: \$40.00 Permit #5: \$55.00 Permit #3: \$45.00 Permit #6: \$60.00 + \$3.50 processing fee for all permits
<i>Guest Permit Quantity</i>	Up to two (2), not to exceed six (6) total permits per household, inclusive of residential permits.
<i>Guest Permit Cost</i>	The cost of guest permits will be determined based on the total number of permits and will reflect the rate structure of Residential Permits
<i>Temporary Permit Quantity</i>	Unlimited daily permits
<i>Temporary Permit Cost</i>	\$3.00 + \$3.50 processing fee
<i>Residential Permit Quantity</i>	One (1) permit per licensed driver, not to exceed six (6) total permits per household, inclusive of guest permits.
